Introduction

Each year the State Records Office of WA (SRO) marks Western Australia Day by publishing online a Guide to State Cabinet records which have been released from their 30-year restriction access period in the previous calendar year. This year's Guide lists all matters minuted in State Cabinet meetings held in 1987.

State Cabinet records are historically significant documents which reveal the decisions made by the government of the day. These unique records are the primary source documents for information about the issues raised at Cabinet meetings. This online Guide is intended to assist the Western Australian community with access to these records.

This online Guide also provides an overview of Western Australian state issues in 1987, as well as highlighting a few of the more prominent national and international news events of that year. A list of the topics and subjects discussed at each meeting of State Cabinet in 1987 is provided in this Guide to encourage further research into the records. This list includes a link to the SRO's online catalogue to enable online requests to order, view and digitise relevant records.

Unlike the release of Cabinet papers at the Commonwealth level, where records comprising more sensitive information can be embargoed beyond the restriction access period for the remaining records, all of the State Cabinet records for Western Australia are released for public access 30 years after the records are created.

N.B. This year (2018) the Guide to the 1987 State Cabinet Records has been produced with the assistance of Mr Trent Bersan, a return to work participant at the SRO. Mr Bersan researched the 1987 State Cabinet Minutes and Decisions and compiled and drafted the list of Cabinet meeting subjects (see pp.10 - 40) during his placement at the SRO.

Description of the 1987 State Cabinet Records

The primary set of State Cabinet records referred to in this Guide is called 'Cabinet Minutes and Decisions.' State Cabinet Minutes and Decisions include agendas and submissions to Cabinet and are listed chronologically. They record the meetings of State Cabinet held between 12 January and 22 December 1987 inclusive, and are described on SRO's catalogue as [State Cabinet Minutes and Decisions \(Series 1228, Consignment 4736\)](#). Other State Cabinet records which complement the Minutes and Decisions, include [Cabinet Meeting Summaries for 1987 \(Series 1230, Consignment 4823, item S05\)](#), and submissions, reports and other accompanying documents to the Minutes and Decisions, each of which is described as a "[Cabinet Record](#)" (Series 1228, Consignment 6150).

Cabinet Minutes and Decisions

State Cabinet Minutes and Decisions are the primary original source documents that reveal government decisions made at Cabinet meetings. These documents contain the names of the Ministers present and absent at each meeting, supporting reports, copies, summaries or reviews of submissions, and a record of ministerial recommendations, and relevant decisions, approvals, deferrals and rejections by State Cabinet.

World Events that Made the News in 1987 ⁽¹⁾

1987 was the year that United States President Ronald Reagan challenged Soviet Premier Mikhail Gorbachev to tear down the Berlin Wall. It was also the year that the 'Iran-Contra Affair' came to light in the U.S. when it was revealed that officials in President Reagan's administration had secretly facilitated the sale of arms to Iran, then under an arms embargo, to fund the Contras in Nicaragua - something prohibited by Congress. The complicated deal also related to negotiations for the release of hostages held in Lebanon. In October stock markets crashed around the world causing a loss of value of over 40% in the Australian market. Several Western Australian entrepreneurs fared particularly badly in the crash which had ramifications for the WA government later in the year.

In March 1987 the television soap opera series 'The Bold and the Beautiful' first appeared on American TV. In April that year 'The Simpsons' made its first appearance as a series of clips on The Tracy Ullman Show. After a 13 year break the next series of the Star Trek franchise made its reappearance in 1987 as 'Star Trek: The Next Generation'. At the Academy Awards in Hollywood *Platoon* won Best Picture and *Take My Breath Away* from *Top Gun* won Best Original Song.

Australian and WA Events that Made the News in 1987 ⁽¹⁾

February 1987 saw a couple of firsts in Australia, with the swearing in of Mary Gaudron as the first female Justice of the High Court of Australia, and the first mobile phone call being made. A double dissolution Federal election was called in late May, with Bob Hawke's Labor government increasing its majority, due in part to the 'Joh for Canberra' campaign which saw Mr Bjelke-Petersen, the Queensland Premier, split the conservative vote. In August the mass shooting called the 'Hoddle Street Massacre' occurred in Melbourne which resulted in the deaths of 7 people and the wounding of 19 others.

A national identification card called the 'Australia Card' was proposed by Federal government in 1987 but popular opposition to the idea of an identity card saw it scuttled later in the year. Joh Bjelke-Petersen resigned as Queensland Premier in December and later the same month 19 year old Kylie Minogue released her first single 'I should be so lucky'.

In WA in 1987, if you went shopping for golf clubs at Sports City a Spalding 'Dot Plus' golf set cost \$499. John Goldie Holden was selling a new model Holden Barina at \$11,490 and Ezywalking had Adidas tennis shoes at \$35 a pair. Four Square supermarkets had Whiskas cat food at 69c a tin and Cheap Foods had tomato sauce at 95c. Golden Swan Cruises had twice daily trips to Rottnest at \$10 per person one way.

On 22 December WA Premier Brian Burke announced that he would retire as Premier and from Parliament in February 1988. Peter Dowding was chosen as Premier-elect by the end of 1987.

Events and Issues in WA Politics in 1987⁽²⁾

February 1987 saw the resignation from the Burke Ministry of the Hon. Des Dans MLC, the third ranking member of the government, and Terry Burke MLA, the Parliamentary Secretary to the Cabinet. In May three by-elections occurred; two of these in seats held by the Labor Party recording swings of 6-8% against it. Cabinet reshuffles resulted in Vietnam War veteran Hon. Graham Edwards MLC entering the ministry in March.

Some of the issues dealt with by State Cabinet in 1987 included consideration of the Kelly Report which recommended an extension of trading hours. This was rejected by Cabinet which cited a survey of metropolitan retailers. The America's Cup and accompanying Festival of Sport were topics discussed in January and February, Dennis Conner's team from the USA taking back the America's Cup on 4 February. Clearing for the site of a new maximum security prison at Casuarina commenced. Initiatives were discussed relating to the impact of a rural recession on local communities. Proposals to redevelop the old Swan Brewery site on Mounts Bay Road were opposed by the Town Planning Committee of the Perth City Council, and the Minister for the Environment, Mr Pearce, criticised the National Trust for supporting the demolition of buildings on the site. The stand-off resulted in the State government considering setting up a planning authority for central Perth which could reduce the planning powers of the City of Perth.

The second half of the year saw State government intervention in the economy due to issues relating to the management of the Swan Building Society and the Teachers Credit Society, or from repercussions of the October stock market crash. This had various ramifications such as a run on the Challenge Bank in late October and a guarantee by State government of Rothwells merchant bank to back up a rescue package put together by a consortium of businessmen. Another intervention was the purchase by the State Government Insurance Commission of property in Perth owned by the Bell Group. But State Cabinet minutes and decisions reveal a relatively steady as you go approach throughout this period.

Pesticide residues in Western Australian meat, putting at risk the export market, were of great concern to the government and fostered bans of DDT in the State. A certain degree of electoral reform was achieved by the government in 1987, with the Legislative Council to be elected using multi-member regional electorates in future. Aboriginal matters also dominated Cabinet proceedings in 1987 with reports about public service Aboriginal employment policies being considered by Cabinet, a government committee on Aboriginal/Police and community relations being formed, the Aboriginal Police Aide scheme being reviewed, and a proposal for Aboriginal joint management of the Bungle Bungle National Park being also considered.
